#### **Key to Sections**

- 1. **End-of-Month Pay** This is the actual amount you'll see paid out at the end of the month.
- 2. **Entitlements** This lists a Service members' entitlements and allowances.
- 3. Federal Tax Withholding Status Contains information regarding a Service members' tax information/status.
- 4. **Allotments** Specifies authorized deductions allocated by the Service member.
- 5. **Year to Date (YTD) TSP Contributions** Details retirement savings contributions from various pay components.
- 6. **Duty Station ZIP Code** The ZIP code used for computation of Variable Housing Allowance.
- 7. **Years of Service** In two digits, the actual year of creditable service.
- 8. **Deductions** Itemizes all amounts withheld from the Service members' paycheck.
- Current Leave Balance Details the Service members' accrued leave status.

## **Key to Sections**

- 1. **Forecasted Pay** The actual amount to be paid out at month's end.
- 2. **Remarks** Lists entitlements, deductions, and payments. Also contains comments on specific earnings data.
- 3. Federal Tax Withholding Status Lists marital status and number of exemptions, total federal taxable income for the period covered, federal taxable income year to date, and total amount of federal income tax withheld for the year.
- 4. **TSP Contributions YTD** Details on tax-deferred, exempt, and Roth contributions.
- 5. **Duty Station ZIP Code** Contains the ZIP code your BAH is based on.
- 6. **Years of Service** Total number of years of service.
- 7. **Deductions** Itemizes all withholdings from the Marine's paycheck.
- 8. **Current Leave Balance** Details the Marine's accrued leave status.
